The 13th BOS meeting was conducted online (Google meet) on 05th October, 2024 between 11.00 am to 1 pm. BSc first-year Semester I, Semester -II, Vocational Education Course (VEC) & Semester -IV syllabi were discussed. These courses are designed as per NEP 2020.

Meeting started with reviewing minutes of 12th BOS meeting held on 16th March 2024.


The minutes were unanimously approved by the members.

Dr. Meeta Saxena shared the status of department as a minor subject under NEP 2020. She shared the syllabus of First year (3 subject combination) for semester – I

and semester II, second year Physics minor semester – IV syllabus which was approved by all the members. Ms. Iqra Shaikh endorsed the Vocational Education Course (VEC) syllabus, highlighting its focus on environmental sustainability. Dr. Pravin proposed organizing a guest lecture in the department. Dr. Pushpinder suggested the introduction of a skill enhancement session to improve student engagement and understanding of the subject. Dr. Dongre commended the inclusion of educational visits, small projects, and report writing, literature surveys in the syllabus, emphasizing their educational value. Members approved the syllabus of FY semester – I, II (with three subject combinations), Vocational education course (VEC) as well as S Y semester – IV as per NEP.

Dr. Meeta shared the assessment and evaluation pattern, which were also approved by the members. Chairperson, Dr. Saxena requested members to authorize her, for modifying/ tweaking the syllabus (if needed) as per the revised NEP norms as adapted by the college. This was approved by members.

Meeting was concluded with the vote of thanks to respected BoS members.


