ASSESSMENT DETAILS:

Internal Assessment (50 marks)

Semester End Exam (50 marks)

Duration: 2 hours

- 1. The Question Paper will cover all five units of the syllabus.
- 2. There will be three mandatory questions:
 - Question I : Attempt any two out of four (30 marks).
 - Question II: Attempt any one out of three (10 marks).
 - Question III : Attempt any two out of four (10 marks).
- 3. In each question, each option will be from a different unit.
